## Message From the East

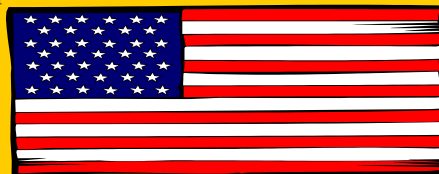
Greetings Brethren,
